1 1. Students who are planning to attend an *accredited technical college or two-year community* college must complete this four-page application (attach additional sheets if necessary). Your name and address should be on all attachments. Completeness and neatness ensure your application will be evaluated appropriately. 2. Copy of your recent academic transcript. To gualify for a technical college or two-year community college scholarship, you must have a high school cumulative grade average of at least a 2.5 on a 4.0 scale to apply. 3. ACT and/or SAT exam scores are not required to be considered for a technical college or two-**Checklist** year community college scholarship. 4. Handwritten guestions – You must legibly handwrite a one paragraph answer to each of the following questions. To qualify for a scholarship, students must not use Chat GPT or any other artificial intelligence assistance program. If it is determined that an artificial intelligence assistance program is used to answer the following questions, your scholarship application will be disgualified. Letter of Reference – Include a letter of reference from a teacher, school counselor, employer, youth leader, or pastor. 6. Application must be signed by both the parent or guardian for the student to be considered. The parent or guardian must be a Sioux Valley Energy member.
