Discussion was held. Mr. Rogen made a motion to authorize the Chair and Secretary to execute the RUS building contract with Hegg Construction, seconded by Mr. Roskamp. The motion carried.

Manager McCarthy stated that the agenda is being developed for the July 18, 2023 strategic planning session.
